A. CONTINUING BUSINESS -

1. Teacher Salary Increase Proposal: During the 2020 legislative session Governor DeSantis and legislative partners passed the Teacher Salary Increase Allocation through House Bill (HB) 641. Each charter school governing board shall submit an approved salary distribution plan by November 11, 2020. The FLDOE recommended formula for calculating the Teacher Salary Increase was presented.

A motion to approve the Teacher Salary Increase Proposal was made by Amy Miller and seconded by Ryman Shoaf. The motion was approved 5-0.

B. NEW BUSINESS:

- 1. Property Acquisition: Presented by Amy Miller an update on the potential acquisition of addition property, specifically the necessity to conduct a wetlands survey based on the water management district review. Cost \$900.

 A motion was made by Jim Horne and seconded by Carlyle Martin to approve the expenditure of \$900 for a wetlands survey prior to considering an offer. The motion was approved 5-0.
